#### PROCEEDINGS – June 12, 2023 TOWN OF CHASE BOARD OF SUPERVISORS MEETING

## 1. Call to Order and Roll Call

- **C. North Chase Citgo** Motion by Van Enkevort/Kroll to approve North Chase Citgo Liquor License renewal. Motion was called and carried 3-0.

Delebreau stated that the Town was awarded a \$4,788/09 grant from the DNR that was received on June 7, 2023. He also thanked Seivert's Dairy Farm for donating \$150 for the ATV/UTV application fee.
